⁴ Schools where at least 40 percent of the lunches served during the second preceding school year were free or reduced price qualify for extra "severe need" school breakfast reimbursements. New schools may qualify if it is determined that the 40 percent free or reduced price requirement would have been met in the second preceding year [7 C.F.R. 220.9 (d)].

⁵ According to the School Nutrition Association, the 2006-07 national average for a school lunch was \$1.80 (\$1.66 for elementary schools; \$1.85 for middle schools and \$1.90 for high schools).

⁶ These reimbursement rates do not include the value of commodities (or cash in lieu of commodities), \$0.1875 for the period 7/1/07 through 6/30/08, which institutions receive as additional assistance for each lunch or supper served. Federal Register, Vol. 72, No.142, 7/25/07, p. 40826-40827. [Adjusted annually based on the Price Index for Foods Used in Schools and Institutions.]

⁷ Applies to schools where 60 percent or more lunches served during the second preceding school year were free or reduced price.
